# About the OSI/ IHRD Commercial Sex Worker Initiative


conomic and political changes over the past decade have created extreme financial hardship in Eastern Europe and former Soviet Union, particularly for women. These difficulties have resulted in a dramatic increase in the number of women and girls in the sex work industry, either voluntarily or against their will. Some are illegal foreign immigrants fleeing hardship and poverty in search of a better life; others are the victims of trafficking and sexual exploitation. One thing they all share is an expanded risk of HIV infection.

According to researchers, those with the least amount of control over their working environment are the most vulnerable to HIV and other sexually transmitted diseases. This tends to be younger sex workers, women who are linked to pimps and those selling sex on the street. Data also indicate a strong correlation between commercial sex work and drug use. Some drug users turn to sex work out of financial necessity to support their addiction, while sex workers often seek an escape from their harsh lives through drug use. The desperate exchange of sex for drugs or drug money is a high-risk encounter that reduces appropriate judgment around safer sexual behaviors. And clearly, the sharing of needles and syringes is a well-documented mode of HIV transmission.

In recognition of the need to provide targeted HIV prevention services to commercial sex workers (CSWs), the International Harm Reduction Development program (IHRD) announced the first of two related calls for funding proposals in May of 2000. The first grant competition (known as "Part A") sought to enable organizations that provide social care and/or medical services to sex workers to add-on or enhance drug-related harm reduction efforts. These activities would aim to reduce the harms associated with illegal drug use that are based on a respectful and non-judgmental approach to drug users and could include: staff training on drug-related issues; needle exchange and other HIV-prevention efforts; development of health education materials for drug users; provision of condoms, bleach kits and other necessary items; targeted outreach and support services for drug users; legal services; and treatment referrals for women and men selling sexual services.

A second call for proposals was issued to all IHRD/Soros-funded harm reduction projects in June of 2000. This initiative (known as "Part B") offered funding to create new or enhanced activities targeting the needs of sex workers. These activities could include: staff training on sex worker issues; development of health education materials for sex workers; targeted outreach and support services for sex workers; legal and medical treatment referral services for women and men engaged in sex work; and expanded needle exchange and replacement therapy services targeting sex workers.

With the help of an expert review committee and critical input from the Public Health Coordinators at the national Soros Foundations and UNDP partner offices, IHRD screened more than 60 applications from 18 different

countries. For Part A, 10 organizations were selected in: Belarus, Bulgaria, Estonia, Poland (2), Romania, Russia, Turkmenistan, Ukraine and Uzbekistan. For Part B, 23 organizations were selected in: Belarus (1), Bulgaria (3), Latvia (1), Lithuania (1), Poland (1), Russia (8), Ukraine (7), and Slovakia (1). Direct service funding for the entire initiative totals more than \$335,000, and activities were launched at the end of 2000. There is no guarantee of multiyear funding.

Because this is a pilot effort, IHRD developed a comprehensive evaluation component. All 33 CSW projects were asked to submit quantifiable objectives that describe the number of staff and volunteers to be funded by the grant; the number of clients to be reached; the services to be delivered; and the organizational capacity to be developed.

To assist the CSW projects in meeting their goals, IHRD has created a technical assistance package that includes the following:

- IHRD works with a team of Technical Advisors (TAs). Most of the TAs live and work in CEE/FSU, and have exceptional experience in the design and delivery of harm reduction services. The TAs will visit the projects and offer needed assistance. They will especially focus on linking Part A projects with the broader harm reduction network in their respective countries and regions.
- All projects will be invited to participate in IHRD's training program. Over the next 18 months, a total of 7 different trainings are being offered to the 150+ harm reduction projects that IHRD helps to support. Each of the 33 CSW projects can send 2 people to a choice of 3 different trainings. The training topics are: organizational development; evaluation, research and technology; HIV issues; women and drug use; overdose prevention and safer injection; outreach, secondary exchange and drug education; and serving minorities and community outreach.
- The 10 Part A organizations will be invited to participate in a special workshop on harm reduction and sex worker issues. IHRD has identified a training team to facilitate this effort and arrange appropriate site visits.
- IHRD wants to support linkages among the 33 CSW projects and between the CSW projects and existing networks that address sex work issues in both the East and West. All grantees will receive ongoing updates about sex worker-related issues, including access to educational materials, research reports and conferences. Additionally, IHRD will support project staff to participate in skills building seminars and meetings, as much as possible. Beyond direct service funding, IHRD has made grants to several organizations addressing CSW issues, such as supporting the European Project AIDS and Mobility for their upcoming conference entitled, "East-West mobility in Europe: Overcoming barriers to HIV prevention for migrant sex workers."
