• Establishment of the RWCT (Reading and Writing for Critical Thinking) International Consortium.

Coming together in Vilnius (Lithuania) on March 15, 2004, representatives of 22 organizations from 22 countries (Albania, Armenia, Azerbaijan, Belarus, Bulgaria, Croatia, Czech Republic, Estonia, Georgia, Kyrgyzstan, Latvia, Lithuania, Moldova, Mongolia, Romania, Russian Federation, Serbia and Montenegro, Slovakia, Slovenia, Tajikistan, Ukraine, Uzbekistan) signed the Agreement of the RWCT International Consortium.

The RWCT International Consortium provides professional development opportunities for educators who bring up highly motivated and well educated citizens capable of critical thinking, setting and achieving their own and community goals, and bearing social responsibility.

As a network of in-country nongovernmental organizations, building on the efforts of its members, the Consortium strives for:

- Educators to become promoters of critical, creative and caring thinking, education for all, civic literacy and democratic society values.
- Students and parents to become active participants of the teaching/learning process aimed at successfully meeting the challenges of the 21st century.
- Educational administrators to foster these efforts and help in establishing stronger connections with authorities at all levels, in securing media promotion and strengthening community bondages.
- Society members to become supporters of lifelong learning, as a tool of coping with an ever-changing society.

SERBIA

Suspension and Revision of International Projects by the Ministry of Education

Ministry of Education met with donors and creditors (source: Web Site of Serbian Government)

Belgrade, April 2, 2004 - Serbian Minister of Education and Sport Ljiljana Colic held a meeting with foreign donors and creditors and briefed them on Ministry's plans and priorities in the implementation of education reform.

Colic said that in the creation of a new system of education, the former Ministry paid special attention to teacher training in the form of seminars and workshops in order to improve communication between educators.

She said that her post as new education minister implies an analysis of the work of the previous ministry and ways in which allocated funds were used. She said that the results of this kind of funding are visible and do not require special analyses, but that programs of seminars and their results need detailed examination.

Colic said that the Ministry is aware of the fact that the seminars are part of international projects that have been launched, and informed donors and creditors that the seminars will be suspended until professional teams engaged by the Ministry make changes in this kind of education. She added that the Ministry has had no intention at any moment to end cooperation with foreign partners.

GEORGIA

• International Conference on Project Development – "Evaluation of the Level of Integration and Harmonization of the Countries of the South Caucasus with 1997 Lisbon Convention"

Tbilisi, Georgia

April 2-3, 2004

The International Institute for Education Policy, Planning and Management, Georgia participated in the Eurasia Foundation grant program to support public policy research and legislative recommendations for integrating the South Caucasus Countries with the European conventions and norms. The main objectives of the project were to carry out a survey assessing the South Caucasus countries' integration and harmonization with international structures in the higher education and compliance with Lisbon Convention on Recognition of Diplomas and Degrees in Higher Education, as well as marketing of the survey results and advocating for the adoption and implementation of the convention standards and policy recommendations. The Institute is implementing the project on the regional level, in close collaboration with its partners from Armenia and Azerbaijan.

In the framework of this effort, the Institute held international conference on April 2-3, 2004 in Tbilisi, Georgia. Foreign experts of education, specialists from the South Caucasus countries as well as representatives of the corresponding local and international organizations had participated in the event. The two-day conference examined main developments in the higher education systems of the region, analyzed the preliminary results of the project, and planed follow-up activities in close collaboration with donor community and relevant stakeholders.

• On March 20, 2003, Centre for Public Policy PROVIDUS had organized a round table discussion on Education Reform in Latvia. The main aim of the discussion was to find if there is a common platform for the future of the reform? Considering that lately the discussion of the reform was overly politicized, PROVIDUS attempted to make this discussion on professional grounds. The participants of the discussion were - the Minister of Education and Science, representatives from the Ministry of Integration, local educational Authorities, directors from minority schools and representatives from NGO. It was agreed that all sides acknowledge learning Latvian language at the secondary school level. However, the teaching of language should not be forced upon minority schools. There is an idea to promote bilingual education not only in schools with Russian language of instruction, but also in schools with Latvian language of instruction. Although further dialog is needed to clarify and agree of the aims of the reform of education in Latvia, as well as are the minority school teachers ready for the reform. - The British Council Kazakhstan-Kyrgyzstan is supporting KEIF 2004 (Kazakhstan International Educational Fair); this is the second time that Intellect Consulting Educational Agency has organized the Fair in Almaty. Intellect Consulting Educational Agency is ready to welcome universities, colleges, boarding schools and language schools from all over the world to Almaty. Building on the experience of the first Fair, the Agency is aiming to attract more prospective students this year, in order to increase the number of students from Kazakhstan at UK educational establishments. More than

3000 visitors attended the Fair last year. There were 25 participants, schools as well as universities, from 11 countries including the UK. The UK is still the most popular overseas destination for Kazakhstani students who want to go to language schools, colleges and universities. OECD (Organization for Economic Co-operation and Development)

Education Ministers from OECD countries met in Dublin on 18-19 March 2004

In introducing the theme, Minister José David Gomes Justino pointed to the twin challenges of widening access to education and raising levels of performance. He invited participants to reflect on key policy levers that could help to address these challenges and raise educational quality for all, including formulating educational goals and monitoring adherence to these; fostering learning environments and models of school governance that are conducive to innovation; and allocating human and financial resources in ways that enhance an equitable distribution of learning opportunities. He particularly stressed the importance of creating knowledge-rich schooling systems in which those responsible for delivering educational services act as partners and have the authority to act, the necessary information to do so, and access to effective support systems to assist them in implementing change. This would require the right balance between internal and external evaluation and between co-operative and competitive approaches. He invited the OECD to help governments in sharing experiences with the development of dynamic benchmarks and effective support systems as well as policies for educational improvement. He concluded by suggesting that success be defined not merely in terms of current performance levels but also by the progress individual schools are making. Click for more information on this topic

European Comission

A new generation of Community program in education and training after 2006

The Commission adopted on 9 March a Communication on "The new generation of Community education and training programmes after 2006". This Communication outlines the content of two major new Community programs in the field of education and training, which the Commission will formally propose in the summer. These are:

- An Integrated Program in Lifelong Learning, for mobility and cooperation between EU, EEA/EFTA and Candidate Countries, which will subsume the existing Socrates and Leonardo da Vinci programs.
- A Tempus Plus program, for the countries neighboring the EU and for the existing Tempus countries, which will focus on cooperation and development in higher (university-level) education, vocational training, school and adult education.

The Commission proposals build on the experience of the existing generation of programmes, which is summarised in a series of interim evaluation reports published at the same time as the Communication, and on the outcome of a public consultation exercise on the future development of these programmes, which took place between November 2002 and February 2003. Education Commissioner Viviane Reding told reporters that these programmes are designed to play a significant role in transforming Europe into a knowledge economy. She pointed out that Member States must transform words into deeds by increasing significantly the funding available for these mobility programmes. She indicated that a tripling of the budget would be necessary to reach the targets set. Click for more information on this topic

Open Society Institute - Global Supplementary Grant Program

The Scholarship Programs are pleased to offer supplementary grants to students from selected countries of Central and Eastern Europe and the former Soviet Union. The purpose of the program is to enable qualified students to pursue doctoral studies in the humanities and social sciences at accredited universities in Western Europe, the Middle/Near East, Asia, Australia, and North America.

Grants will be awarded on the basis of academic record, merit of the proposed study, applicant's long-term goals, and financial need. The grants will provide supplemental funding for one year of study with the option to apply for a second year. Reapplication procedures will be outlined in the 2005/2006 application form. Renewal grants will be competed with the general pool of applicants and are not guaranteed. Only students who have been accepted into a full-time doctoral (Ph.D.) program at an accredited university are eligible to apply.

International teaching faculty can still apply to teach at the International Summer University Macedonia (ISUM 2004) in Macedonia. The ISUM 2004 (pilot project) offers teaching positions only for professors from EU member states and South East European countries in the field of Law, Public Administration, Economics, Business Administration and Education. Visiting professors voluntarily teach the intensive courses, usually comprising 15 teaching days. Professors receive an allowance of 75 Euros per week. Travel expenses are reimbursed and free accommodation is provided. The target group consists of (senior) students and (young) academic staff. Courses start on 12 July 2004.
